A. CALL TO ORDER

Mayor Rennemeyer called the meeting to order at 1:41 p.m.

The executive session was closed and the Town Board returned to the Special Meeting.

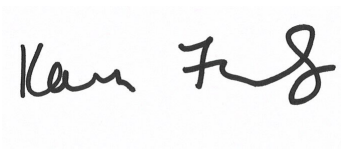
C. RETURN TO OPEN MEETING
